

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to desotobeecompany.com, and Desoto Bee and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Desoto Bee include desotobeecompany.com. The Desoto Bee website is an agent portal and company information site. Collection of your Personal Information
